ENGLISH MOUNTAIN DEVELOPMENT AMENDMENT TO DECLARATION OF PROTECTIVE COVENANTS

KNOW ALL MEN BY THESE PRESENTS THAT WHEREAS the English Mountain Development is subject to certain Protective Covenants of record in the Sevier County, Tennessee, Register of Deeds Office (ref. Book 38, Page 12); and

WHEREAS, the English Mountain Property Owners Association, Inc., a Tennessee Corporation, is the successor in interest of the original developer, Preferred Development Corporation, under the Protective Covenants as to governing and enforcement rights for the use, benefit, and preservation of the development, having exercised those rights since its formation as an Association of owners and the abandonment of the developer; and

WHEREAS, the Association, through a vote of its membership, has determined it advisable to amend the Protective Covenants, as such successor in interest, in an attempt to clarify and conform the Protective Covenants to the actual functions and governance of the Association;

NOW, THEREFORE, the Declaration of Protective Covenants for English Mountain Development are hereby amended by adding the following language:

The English Mountain Property Owners Association ("EMPOA" or "the Association"), is vested, granted, and empowered with all enforcement, governance, architectural review, and similar rights set forth in these Protective Covenants as previously held by the Developer. As the context may allow, any reference to Preferred Development Corporation or "Developer" in these Protective Covenants relating to such enforcement, governance, architectural review or similar rights shall be deemed deleted and supplanted with the name of the Association.

The Protective Covenants are further amended whereby any references, statements, or provisions asserting that Preferred Development Corporation or any "developer", has any controlling or governing rights or ownership interest in any common area or roads in the English Mountain Development are deleted, void, and for naught.

These amendments were adopted and approved by a vote of the membership of the Association at the Annual Meeting held on July 9, 2011.


